Finance Committee Report

Vivian Kossuth SACPA Board Treasurer presented the finance report

Vivian pointed out a mistake under misc., which should be a \$939.48 balance (from printed \$439.48) by removing \$500 from speaker fees.

Lunch fees will go up to to \$12.00 in September.

Questions from the floor

Question from Joseph Hnatiuk: Is there a limit to amount paid on speaker fees, as SACPA should have a limit. Knud Petersen answered that for SACPA's 50th anniversary year the limit on speaker fees/travel costs will be \$8000. Next year and in future years SACPA's regular budget allocates \$2000.00 for travel expenses and no speaker fees unless in special circumstances.

Trevor Page asked whether there is a cap on speaker fees?

Knud Petersen answered that SACPA has no cap, but has paid very few speaker fees in the past.

Trevor Page asked why the 50th anniversary year proposed budget is covering 2 years?

Knud Petersen answered that SACPA will be starting to spend money this coming fall already so costs will be spread over 2 years. (2016/17 and 2017/18)

Knud explained university reimbursement process of travel expenses for Dillon Black and Erin Leigh on the Cyber Violence session.

Program Committee Report

Terry Shillington presented the Program Committee report.

Questions from the floor.

Josephine Aristone asked if SACPA have speakers lined up for next season which is Canada's 150th anniversary.

Terry Shillington answered that Alberta's Health Minister, Sarah Hoffman may be coming, but SACPA's board is actively working on this.

For SACPA's 50th anniversary, the board is working on several speakers and some of them will be addressing topics related to Canada's 150th anniversary.

Policy and Bylaws Committee Report

Knud Petersen presented the Policy and Bylaws Committee Report.

Questions from the floor.

Knud Petersen suggested that this would be a good place to discuss the concerns raised earlier about moderators. Terry Shillington mentioned that moderators are not picked at the start of the season. SACPA does the training informally before the start of the session.

Trevor Page suggested that the board maintains the excellence of SACPA. Congratulates SACPA on excellent sessions and mentions that some moderators are not doing their moderating duty. Trevor also feels that the lunch quality has decreased. Will the lunch fee increase also increase the quality of the lunch? How does SACPA come to the decision to raise lunch fees?

Knud Petersen answers that the increase reflects the current level of inflation. Larry Elford, on behalf of SACPA, will discuss with Country Kitchen Catering re meal quality and expectations.

Henning Muendel suggested that there be a buddy system organized to take on training of upcoming session moderators.

Bev Muendel-Atherstone complimented Country Kitchen staff and the generally good quality food for such reasonable cost.

She would work closely with a research student that William Ramp at the University is providing.

SACPA is also considering the creation of a video.

SACPA will pursue a grant from the "150 Canada grant" for \$5000.

Larry Elford asked if SACPA has considered bequests and financial contributions.

Knud Petersen answers yes and donations can be made via the SACPA website.

Henning Muendel suggests that Gordon Campbell as a founding members of SACPA be contacted for video or audio.

Terry Shillington mentions that the board has talked about this and is working on this.

2016-17 Chairperson Report

It is my pleasure to inform the membership and others, from my perspective, of what's been happening during the day to day workings of SACPA's board and committees. Now in its 50th year, this durable and proud organization is probably more relevant than ever as issues related to many topics continue to mount. While SACPA tries to cover all sides of the political spectrum equally, we may occasionally be viewed as favouring one side or another, but on balance, we try staying away from "fake news" and "alternate facts".

SACPA hosted 39 regular sessions and 7 special events this past season. Topics had a fairly even mix of local, provincial, national and international issues. Topics discussed were largely balanced around politics, the economy, social, education, health, religion, First Nations issues, refugees, science and the environment. Presenters included 25 women and 27 men, 13 speakers from U of L, 3 from the College and 2 from other universities. Average attendance at regular sessions were 74, down 5 from last year. Seven (four at the Library and three at U of L's Penny Building downtown) special events averaged approximately 25, substantially down from last year.

Many important issues were covered in a timely manner thanks to the SACPA Program Committee and Board including our treasurers **Vivien Kossuth** and since April, **Ross Samuel**, secretary **Bobbi Cullum**, **Bev Muendel-Atherstone**, **Shannan Little**, **Heather Oxman**, **Tad Mitsui**, **Terry Shillington**, **Mark Nelson**, **Martin Heavy Head**, **Duane Pendergast**, **Lisa Hildebrand** and **Larry Elford**. Best wishes to outgoing board members, Bobbi Cullum and Vivien Kossuth, many thanks for their valuable contributions

We continue to work closely with the University of Lethbridge, Lethbridge Public Interest Research Group (LPIRG), Student Union (ULSU) and several other U of L departments when booking speakers. Special sessions at the Penny building however, were not particularly well attended. All three SACPA on Campus 2017 Student Speaker Challenge (SSC) events seemed a little less exciting than last year despite very good efforts and more consistent judging. Planning is underway for the 2018 SSC events.

Many thanks to all board members, 50th anniversary committee members, **Bev**, **Heather and Jaisie Walker**, speakers, moderators, SACPA members, attendees and other supporters of SACPA events including **Lethbridge Herald**, **Shaw TV** and **Lethbridge Public Library**. Thanks also to **CKXU 88.3 FM radio**, **CJOC Radio**, **CTV**, **Lethbridge News Now** and other media for covering many sessions. A special thank you to **Country Kitchen Catering** for making us feel welcome while serving us great value meals with a smile and last but not least to the **University of Lethbridge** for their financial support, distribution of notices and supply of rooms at the Uni and the downtown Penny Building.

Finally, my personal thanks to **Annelies van Oers**, our way overqualified and very friendly administrative manager. She keeps our speakers/moderators in line (despite her broken arm) and collects money as well as looking after the sound, recordings and our website. Annelies is also very well connected in our community and occasionally helps arrange for speakers. Thanks also to **Sheila Rogers** who amply fills in for Annelies when needed.

Sometimes we get so engaged in getting to “the bottom of it”, we forget we have a committee task to do. But the passion and sometimes the disagreement within our committee helps us name the pressing issues of our community, province and beyond.

Often a topic will linger in the air for weeks or months, before we discover the right speaker. We are thankful for the rich people resources of this community, including the University of Lethbridge, that bring insight and expertise to so many subjects.

Attendance alone may not reveal how important a topic is – and at times we are surprised at what draws a crowd, and what does not. This past year we had major turn outs for the following:

Feb. 2, Trevor Harrison explored neo-liberalism, Trump and the return of populism (122)
Nov. 3, Jim Tagg’s talk on the US election (He predicted Hilary Clinton to win) (108)
Jan. 26, Japanese internment camps with George Takashima (102)
Oct. 27, Racism with Joanne Fiske (101)
Jan. 19, Dawn Leite’s presentation on a performing arts center for Lethbridge (99)

Only one Thursday saw attendance drop below 60. Again this year we have many people to thank. Knud brings wisdom and lots of time, as he guides these topics to fruition. Thanks to many board members who chase down a speaker with relentless persistence. Annelies and her tech colleagues ensure we have reliable sound and internet support.

Thanks too to many loyal attenders who come, bringing questions, challenges and curiosity. And not least, we enjoy the food and the personal touch of Country Kitchen Catering management and staff.

We look forward to next fall and another good year. We have established a Gordon Campbell memorial speaker series, and will try to make each of those events special. One certainty is that we will have an abundance of issues that beg to be explored.

The 2016-17 SACPA on Campus committee had another eventful year in which we co-ordinated three special sessions at U of L's Penny Building. On Nov 30, **Jack Mintz** discussed Carbon Dioxide pricing and on Feb 23, we hosted **David Gray** and his talk on how Alberta's electricity prices will be affected by coal-fired power plant closures. **Larry Martin** addressed the need for climate change policy in Canada to be fair on March 22.

SACPA also co-sponsored three other events at U of L. **Gabriel Rosenberg** from Duke University, spoke on the 4H movement in USA on Jan 24 and on industrial reproduction Jan 25. On May 9, **Edward Snowden**, via Google from Russia, presented on privacy issues in a world that increasingly use electronic devices to spy on its citizens. A huge enthusiastic crowd of nearly 600 showed up and SACPA used that opportunity to promote itself by handing out 300+ promo flyers, mostly to folks unfamiliar with our organization.

The SACPA on Campus Student Speaker Challenge committee started organizing in Nov and their work culminated on March 15 with the final event. The candidates were asked to speak on the topic: **Canadian Values: What are they?** Seven applicants competed and after a three event competition dominated by women, the winners were declared and shared \$2000 in prize money.

The success of SACPA on Campus relies heavily on working with both the U of L Student Union (ULSU) and the Lethbridge Public Interest Research Group (LPIRG). **Emma Ladouceur** from LPIRG and **Hailey Babb** from ULSU were extremely proactive and helpful. We hope to continue cultivating this relationship in years to come. Thanks also to the **University of Lethbridge** for their support at on campus events.

SOUND/RADIO/ SHAW

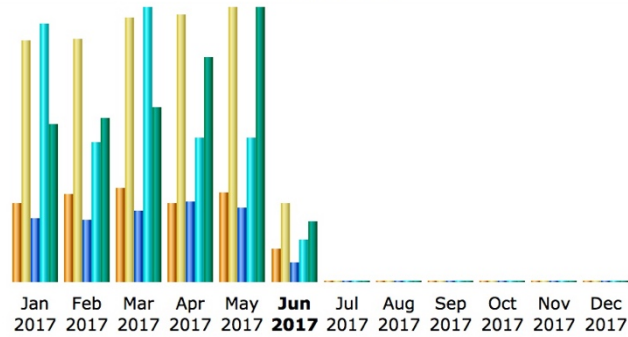

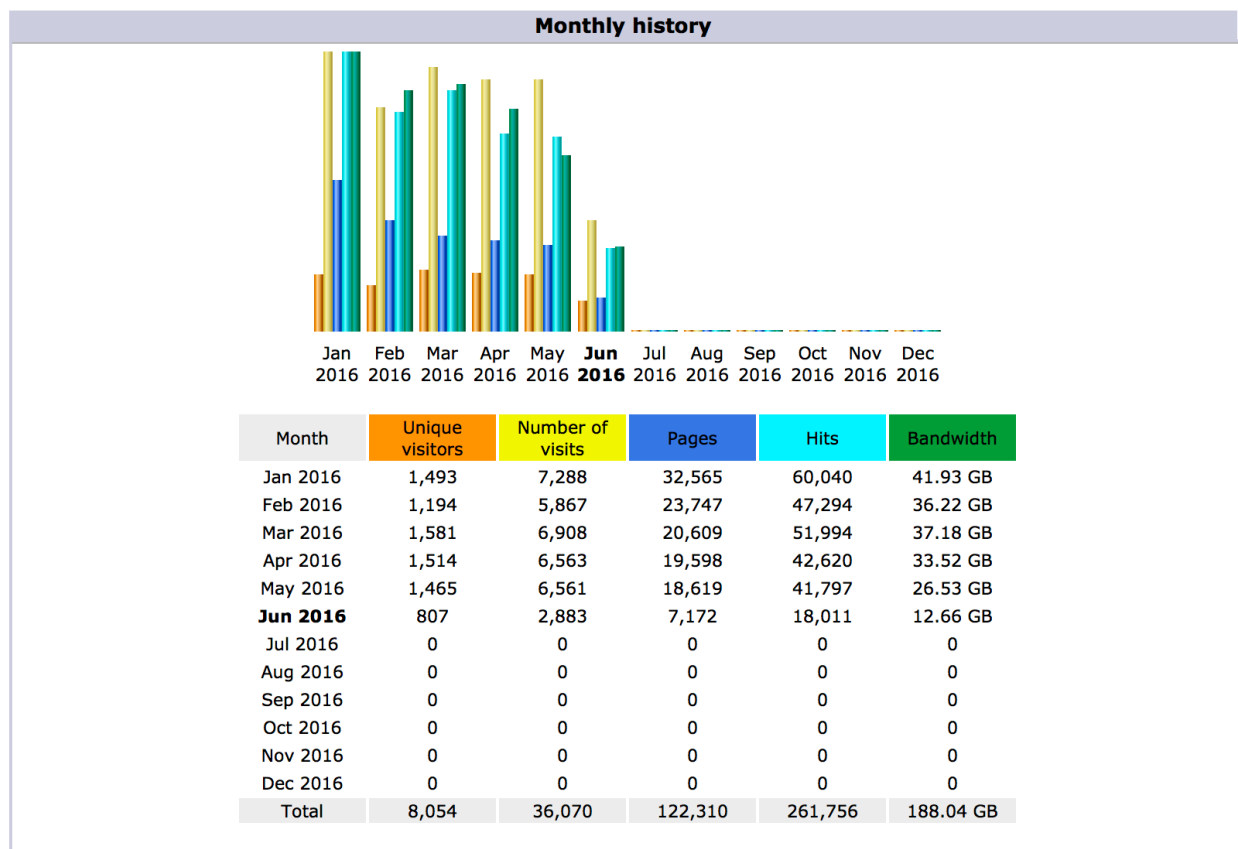

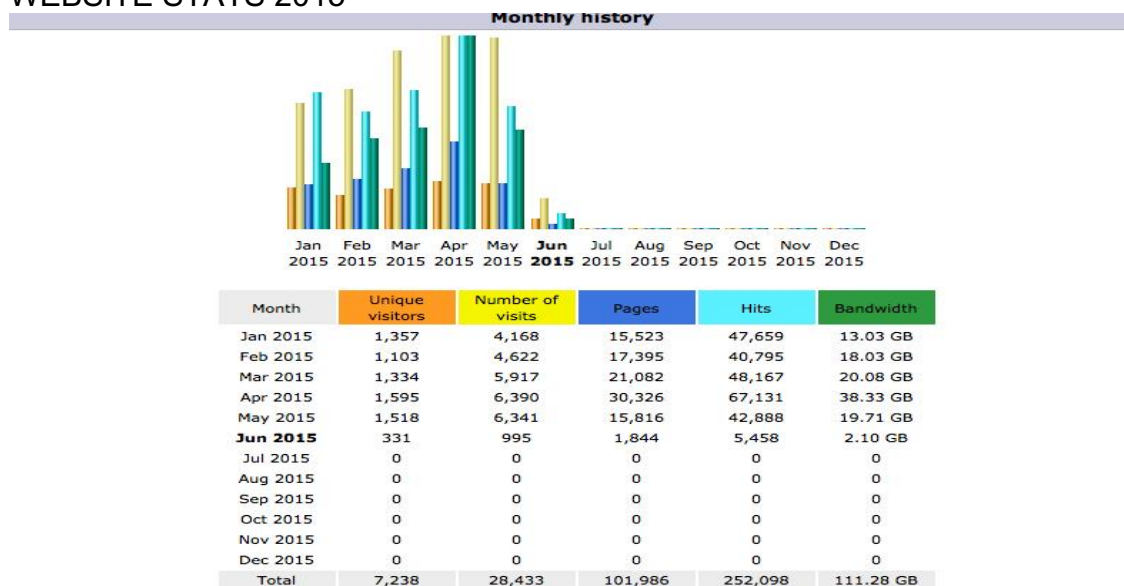

SACPA 50th Anniversary Committee Report

From the last AGM in June 2016, this committee met nearly every other week at the Main Branch of the Public Library during the summer and autumn to discuss and plan the pages of the commemorative publication for the 50th anniversary of SACPA. **Jaisie Walker**, a University of Lethbridge graduate student with Dr. **William Ramp**, was contracted to help with the research and editing, and she provided the creative concept that prevailed in the publication. Eric Dyck, a local artist, provided the art work for the cover, which was used in several other publishing off-shoots, among them, post cards and limited edition posters.

Bev Muendel-Atherstone and **Knud Petersen**, with long term experience in SACPA matters, helped write and review copy and ensured accuracy plus provided lively debate over what should be in the magazine. **Heather Oxman** kept records of all discussions. Since she is relatively new to SACPA, she provided a different perspective for the purpose of the magazine. The magazine came together in January and it was determined that we would publish a large and small version for this anniversary.

In addition to production of the commemorative magazine, there is more work being done to celebrate our 50th anniversary. A letter was sent out in February to over 50 prominent Canadians inviting them to speak at special sessions during this anniversary year. Several have responded and in the coming year, these sessions may be larger scale events, held in collaboration with others. Additionally, we are considering a southern Alberta conference to discuss issues of importance to this and surrounding communities, similar to the very first event launched by SACPA back in 1968. Such an event may eventually be the culmination of SACPA's anniversary year next May or June
